1. TEXTBOOKS

The Library classifies textbooks either by jurisdiction (GO13, GA2 etc.) or according to subject area, examples of which include Comparative law (SG) and Public International Law (SG). Textbooks on Common Law topics for Common Law jurisdictions (Australia, Canada, New Zealand, UK, USA) are shelved in a special section (SJ)

There may be further copies of Short Loan textbooks in the Main Collections on the lower floors. Please check the Catalogue for alternative locations.

3. LEGISLATION AND LAW REPORTS

Primary legislation

The treaties establishing the EC, other amending treaties, acts of accession, the Single European Act and the Treaty on European Union constitute the primary legislation for the EU. A collection of treaties in 2 volumes (English Text), I Treaties establishing the European Communities, II Documents concerning the accessions to the European Communities is available from the Short Loan Collection.

Secondary legislation

A number of different instruments constitute the secondary legislation of the EU. These include:

Directives - to be implemented by law of each member state.

Regulations - automatically law in each member state.

Decisions - binding to those to whom addressed.

Recommendations and Opinions - not binding.

Such secondary legislation is published in the Official Journal of the European Communities

Official Journal of the European Communities (OJ)

" L " series (Legislation) FOL GO1.A1.E(a)1

This series lists secondary legislation, legal instruments or Acts which are divided into regulations ("whose publication is obligatory") and directives, decisions, recommendations and opinions ("whose publication is not obligatory").

" C " series (Information and Notices - Communication) FOL GO1.A1.E(a)1

This series contains texts of resolutions adopted by the European Parliament, minutes of proceedings of the European Parliament, parliamentary questions and answers, judgments of the Court of Justice, the current exchange of the ECU, draft legislation, and opinions of the Economic and Social Committee and of the Court of Auditors

Index

The official index, indexes all the "L" series and some parts of the "C" series.

The index is published in monthly parts which are cumulated annually. There are two separate parts: an alphabetical index arranged by subject and a methodological index arranged by number of the legal instrument.

Commission Documents (COM documents)

COM documents publish the EU Commission's official views on Union matters. They include: the Commission's proposals for legislation, views on general policy, annual reports from various bodies and reports on the implementation of policy. Each document is given a unique number e.g. COM (93) 213

final - indicating that this is the final draft of a Commission document no. 213 for 1993. Draft documents are not normally distributed to the general public.

The Library holds a limited selection of older printed COM Docs (pre-2003). These documents are filed in number order and shelved at FOL GO1.A1.J.45

Court of Justice of the European Communities

The Court of Justice of the EC or European Court of Justice in Luxembourg ensures that Community law is observed in each member state, and passes judgments on the interpretation of Community law. Law reports of cases before this Court are published in:

This Court, which began operating in 1989, hears actions brought by EU employees, competition cases and actions for damage. Law reports of cases before this court are published in:
