Method

Westlaw UK > Cases

Party name search: *Barnsley v Noble*. The first result is the Court of Appeal instance. Click on the Case Analysis > Primary References > Legislation Cited

1b. Does Westlaw indicate that any journal articles have referred to this case?

Answer: Yes, three journal articles are listed

Method

Westlaw UK > Cases

Party name search: *Barnsley v Noble*. The first result is the Court of Appeal instance. Click on the Case Analysis > Commentary references > Journal Articles

Westlaw: UK Legislation

2. Look at the Coronavirus Act 2020, s.78. What is the extent of this section (in which jurisdictions is it applicable)?

Answer: England, Wales, Northern Ireland

Method

Westlaw UK > Legislation

Act/SI Title search: Coronavirus Act 2020. Open the act (there are various pieces of legislation with similar titles so be sure to choose the right one). Click on section 78 > provision details > extent

3. Find the Child Trust Fund (Amendment) Regulations 2019/381. What is the commencement date?

Answer: April 6 2019

Method

Westlaw UK > Legislation

Act/SI Title search: Child Trust Fund (Amendment) Regulations 2019/381. Click on 'SI Details' **OR** open reg.1

Lexis Library: UK Cases

4. Find this case: *Loring v Woodland Trust* [2013] EWHC 4400 (Ch). Has it been reported? If so, give the citation of the law report(s).

Answer

Yes. The law report citations are [2014] 2 All ER 836 and [2014] WTLR 593

Method

Lexis Library > Cases

Search for case name: *Loring v Woodland Trust* or citation [2013] EWHC 4400 (Ch)

In the Case Overview two law report citations are given

5. Find the Modern Slavery Act 2015. What is section five of the act about?

Answer

Section five is about penalties

Method

Lexis Library > Legislation

Search for legislation title: Modern Slavery Act 2015. Ensure the 'Act' box is ticked

Click on the first result to see a list of sections
