ALT 1: Minutes, Agenda and Papers of the Committee of the ALT and its Predecessors, 1965-1996

Extent and form: 5 folders; 1 volume

Administrative note: the ALT's activities are run by a Committee comprising an elected Chairman, Vice-chairman, Secretary and Treasurer, plus five elected members and some co-opted members. The Committee of the ALT was established in 1966, replacing a Steering Committee which was set up in 1965 at the first meeting of the law teachers to formulate the policy for the Association.

Scope and content: ALT 1/1 contains minutes and papers of these early committees, plus related papers. Minutes of Committee meetings between March 1969 and March 1974 are wanting (a note to this effect appears in ALT 1/2).

ALT 7: Editions of the ALT *Bulletin*, 1966-2006

Extent and form: 1 box

Scope and content: the *Bulletin* includes minutes and agenda of AGMs, information on annual conferences, reports on Committee meetings, Chairman's reports, lists of Committee and general members, income and expenditure accounts, special features on law teaching, news of other organisations, letters to the editor and notes on publications.

Arrangement: Nos 1-73 of the *Bulletin* were formerly filed with the Conference papers at ALT 6; they have been removed to make a separate series. The repeat numbers 20 and 21 were presumably mistakes and should have been nos 22 and 23. This appears to have been corrected by the issue of no 24. There are also two no 70s; again, presumably an error. Nos 44 and 97 are wanting.

Archival information: Nos 74-96 were passed to the Records of Legal Education Archives by Dr S B Marsh in 1997. Nos 98-117 were passed to the Archives by Phil Harris in 2013.

ALT 8: *Journal of the ALT*; later *The Law Teacher*, 1967-1997, 2011

Extent and form: 3 boxes

Administrative history: the *Journal* was first published by Sweet & Maxwell in 1967. Three volumes were published annually. Its name was changed to *The Law Teacher* in 1971.

Archival history: many of the volumes dated from 1967-1984 listed below were deposited by Professor James Read in 1997. A further set, dating from 1967-1994, was passed to the Archives by Dr S B Marsh in the same year; this set filled the gaps in Professor Read's collection and brought the set of journals up to date to 1997. There is a gap from 1998-2010 and one volume for 2011 which was passed to the Archives Office by Jules Winterton, the Librarian, in 2012.
