Eagle-I (Electronic Access to Global Legal Information) is a compilation of high-quality legal information sources on the internet. It is maintained by IALS Library for the research community in the UK and around the world.

Use Eagle-i to find UK, foreign, comparative and international law research resources on the web, including legislation, law reports, treaties, government information, blogs, journals and IGO/NGO material.

Over 5,000 resources have been selected for inclusion in Eagle-i. A brief description is given for each one, indicating who is providing the website and highlighting key content.

**Description:**

Conflict of laws.net is an interactive news and discussion website for those interested in private international law. It has contributions from scholars from around the world. The archives can be viewed back to 2006 and posts can be viewed by contributor or searched by keyword. There are also short articles on particular topics contributed by scholars and practitioners, an online bookshop and a page of links to other private international law resources. Conflict of laws.net is officially associated with the Journal of Private International Law.




