IALS 03: Correspondence and Papers of IALS Secretary/Librarian 1946-1984

Extent and form: 14 folders (3 archive boxes)

Administrative history: the IALS Secretary and Librarian undertook the administration of the Institute under the direction of the Committee of Management and was also responsible for building up the library. The position was held by K Howard Drake from 1947 until his death in 1967. He was succeeded by W A F P Steiner. In 1971 the functions were separated, with Steiner continuing as IALS Librarian while administrative duties passed to a new Secretary, J A Boxhall.

Scope, content and system of arrangement: the papers listed below primarily comprise a selection of the general and administrative files of K Howard Drake, with a small amount of correspondence of Steiner and Boxhall. Files 1-9 comprise what was left following a weeding exercise in 1974 by J A Boxhall; they were placed in four box files entitled “Current files – earlier correspondence: weeded JB 1974”. The arrangement in the box files was alphabetical and this arrangement has been continued in the series. Some further files with similar markings, which were clearly correspondence and papers of K Howard Drake as Librarian, were found loose in a variety of locations and have been added to the series. Original file titles are listed in inverted commas. Later files have been added, as they were identified, chronologically; these later records comprise files created prior to the separation of administrative functions in 1971.

IALS 04: Secretary/Librarian's Building and Maintenance Files, 1947-1975

Extent and form: 15 folders (2 archive boxes)

Administrative history: the IALS premises at 25 Russell Square were opened on 11th June 1948. The Institute later expanded into No. 26 Russell Square, and in 1956 took over additional premises at 1 Woburn Square. A new filing system (see IALS 05) was instituted for building,

works and maintenance files covering the new building at Charles Clore House, 17 Russell Square, from December 1975.

Scope and content: originally contained in box files marked “Russell Square general repairs, maintenance, building alterations” and “Woburn Square: installation, tenancy”, the files listed below contain the correspondence and papers of K Howard Drake and to a lesser extent of his successors, Steiner and Boxhall. Correspondence is mostly with the University of London concerning the adaptation, refurbishment and repair of the IALS buildings. Original file titles are given in inverted commas. Considerable weeding has been undertaken of some files to remove ephemera and duplicates; where this has occurred files have sometimes been amalgamated.

IALS 05: IALS Secretary's New Building Files, 1959-1982

Extent and form: 18 folders (1 archive box)

Administrative history: the Institute moved into a new building at Charles Clore House, 17 Russell Square in December 1975; the building was officially opened on 1 April 1976.

Scope and content: this series is in part a continuation of IALS 04 in that it comprises building, works and maintenance files of Drake, Steiner and Boxhall. The bulk of the files comprise Boxhall's papers as IALS Secretary, following the division of the dual function of the Secretary as librarian and administrator in 1971 into two components.

System of arrangement: chronological; original file titles are given in inverted commas.

IALS 21: Legal Skills Research Group: Records, 1987-1994

Administrative history: the Legal Skills Research Group (LSRG) was formed in 1989 as a collective enterprise by some of the country's leading researchers into the skills needed for the study and practice of the law. The Group intended that it should act as a resource for professional legal and judicial bodies, users of legal services and institutions providing legal education at all levels, by:

- doing original research on legal skills;
- monitoring and evaluating current and completed research in the field;
- developing and evaluating curricula for the teaching of legal skills and providing information and consultancy services.

The Group was based and funded by the Higher Education Funding Council. It comprises teachers from law schools throughout the country. It has held annual symposia and regular lunchtime seminars, commencing in July 1990, on various subjects. Most symposia papers have been published in IALS working papers. Subjects have included teaching of ethics, incompetence at the Bar, teaching alternative dispute resolution and evaluation of the Bar Vocational Course.

The Group has also undertaken various special research projects, including a 5-year study commencing in 1989 to develop a general methodology for assessing legal skills. Later projects included developing methods for applying the theoretical findings of year 1 of the legal skills project and the development of training videos.

Scope and content: the papers of the Group primarily comprise files of Professor Terence Daintith, Convenor of the LSRG from 1989 to 1994 and Director of IALS.

Access: open

Archival history: in 1995 Professor Terence Daintith, Convenor of the LSRG, 1989-1994, passed the papers to Juliet Fussell, the Group's Secretary. She in turn passed them to the Records of Legal Education Archives in August 1996. In 2020 the Convenor of the group, Professor Avrom Sherr, confirmed that the group was not independent but was managed by the IALS; all records were therefore transferred to the IALS collection in 2021.

IALS 22: Society for Advanced Legal Studies (SALS) - Records, 1997-2013

Administrative history: the Society for Advanced Legal Studies (SALS), established in 1997, was the successor body to the Friends of the Institute of Advanced Legal Studies. The Friends were established in 1989 under the auspices of the IALS to foster the interests of the Institute. SALS, however, was established as a charitable learned society consisting of scholars, practitioners and those involved in the administration of justice from the UK and around the world. Its objectives were to promote and facilitate legal research at an advanced level and in particular to engender greater collaboration between scholars and those involved in the practice of law. The Society sought to achieve these objectives through a number of initiatives including organising and supporting specialised working groups, lectures and conferences.

The Constitution of the SALS provided for an Advisory Council of persons drawn from academia, practitioners and the judiciary from the UK and overseas. During its first year there was a transitional executive committee, chaired by the Director of IALS, and an interim advisory council.

In recent years SALS ceased to be a separate entity, and the associate charity and company were wound up. Management of the SALS was passed to the UOL Development Office.

Scope and content: the collection comprises the archive of the Friends of the Institute of Advanced Legal Studies, SALS minutes and some SALS publications.

Access: open other than material containing personal data, which is closed for 75 years. **Closed items are designated in red.**

Archival history: in 1997 the Society entered into an informal agreement with the Records of Legal Education Archives (now part of the IALS Archives) to deposit its non-current records with the Archives as the need arises. A file detailing the initial 1997 transfer and terms of deposit is held in the Records of Legal Education Project collection at RLEP 08/12. Further deposits, including records of the Friends of the Institute (the precursor of SALS) were deposited in 2002 and 2004. Some administrative records of the SALS were transferred in 2018. In 2022 it was agreed that the catalogue should be subsumed into the IALS Archives catalogue.
