Extent and form: 8 volumes, 32 folders and 43 PDF files

Scope and content: until 2001 this series is predominantly minutes. From 2001 onwards supporting papers are also held in this series, following a change in filing practice. From 2005 onwards a signed copy of the minutes and signed attendance sheets have been transferred to the Archive. In accordance with the original filing practice, these are held with the agenda and papers of the meeting which they document, rather than the subsequent meeting at which the minutes would have been approved. In addition, minutes of the previous meeting is a standard agenda item for each meeting and therefore a copy of the unsigned minutes of the previous meeting is held with the supporting papers.

System of arrangement: five volumes in this series were originally numbered in sequence A1-A5. Several committees used the same minute book. The books were not listed in chronological order and the numbering sequence was probably imposed at a later date (e.g. minutes of the earliest meetings are in minute books A2 and A4). SPTL 01/07 onwards represent later accessions, deposited by Administrative Secretaries of SPTL. Their original filing order has been retained.

Access: open 20 years after last date on file. **Closed items are designated in red.**

A small amount of destruction was undertaken in 1995 of ephemeral material in files which had missed the earlier weeding (nos. **40-44**).

Biographical note: William Lawrence Twining (b.1934) has had a long and distinguished career in law teaching and has been involved in many projects relating to legal education. He was educated at Charterhouse School, Brasenose College, Oxford and the University of Chicago. He has been Lecturer in Private Law at the University of Khartoum (1958-1961), Senior Lecturer in Law at University College, Dar-es-Salaam (1961-1965), Professor of Jurisprudence at the Queen's University, Belfast (1965-1972) and Professor of Law at the University of Warwick (1972-1982). From 1983-1996 he was the Quain Professor of Jurisprudence at University College London. Other activities have included membership of the Committee on Legal Education in Northern Ireland (1972-1974), presidency of the SPTL (1978-1979) and of the UK Society for Legal and Social Philosophy (1980-1983), chairmanship of the Bentham Committee (1982-) and of the Commonwealth Legal Education Association (1983-1993). He has edited the Law in Context series and the Jurists' series and has written and edited many publications concerning legal education, including *Legal Records in the Commonwealth* (joint editor with E Varnden Quick).

William Twining served on several committees of the SPTL, as well as holding office for the Society in the following capacities:

- Chairman, Publishing Committee 1979-1982
