These files cover the greater part of his time with organisation and encompass his roles as Press Representative (from 1959, end date unknown) and Chairman of the Nominating Committee (1971 and 1973); his involvement with the International Journal of Legal Information; liaison with IFLA re IFLA conference; his membership of the Board of Directors; and his presidency (1986-1992).
