Extent and form: 1 folder

Extent and form: 9 folders

Administrative background: the Council is the governing body of the UKNCCL.

Scope and content: the minutes and papers include lists of Council members, treasurers' reports and minutes of the Standing Committee of the UKNCCL. Minutes are not extant for the early years of the Committee.

Immediate source of acquisition: copy minutes of Council from 1953-1968 and from 1990-1994 were found among files of the IALS secretary, K Howard Drake, who was a member of UKNCCL, and relocated here to fill gaps in holdings; papers from 1969-1989 were passed to Professor Read on his appointment as Joint Honorary Secretary. Papers from 1995-2001 were found among the files of IALS Director Barry Rider, a member of the UKNCCL and relocated here in 1995 to fill more gaps in holdings.
